Start of meeting

Ingrid Näsström from Teknikföretagen (CEO of TEBAB) welcomed all participants to the meeting.

- 1. Legal Check list** (encl 1, slide 2-3)
The legal check list was presented and the importance to follow the rules was accentuated.
- 2. Presentation of participants** (encl 5)
All participants presented themselves.
- 3. Swedish regulation model for net tariffs and their impact on investments** (encl 2)
Kenneth Johansson from Ellevio presented the company which originated from Fortum elnät.
Due to political pressure to lower the net tariffs, the regulation model has been changed leading to a 40% lower investment capability. For example the depreciation rate is changed from 40 to 50 years for cables in the new model.
An investment rate of 120 MSEK/month is needed to have a constant age of the Ellevio network.
- 4. Europacables CPR Project** (encl 3)
Dario Giordani from Nexans presented the information part of the CPR-project. Focus in the project is now information and awareness. The main channel for CPR-information is Voltimum. The project time is one year.

Discussion, national experiences of CPR

The Swedish comments can be seen in encl. 1 slide 8.

Class Dca is the main class in Sweden with the acceptance of E-class in smaller houses and C-class in escape routes.

The authorities in Denmark specify the minimum class Eca cables in general buildings.

5. **Information from Europacable** (encl 4)
Volker Went informed - Europacable activities.
Europacable will look into an anti-dumping process against China concerning fiber cables.
6. **Non-compliant products, experiences from the UK** (encl 5)
Peter Smeeth presented the activities made by ACI (Approved Cables Initiative) a company sponsored by the British cable industry. The complete distribution chain is involved.
"Name and Shame" was a hot topic. It is a balance act to handle the result of the tests being made. ACI make regular tests on cable samples from the market.
Discussion: activities in Nordic countries
It was a common agreement that Selcable shall discuss at their board meeting (2019-06-13) the possibility to arrange a first meeting with a Nordic group concerning market surveillance. A legal adviser should preferably be present during the meeting.
7. **Cable drum handling in Sweden** (encl 1, slides 11-13)
Two main activities are ongoing concerning drum handling in Sweden:
 - the cable drums have a label with information of the pooling system
 - The existing drum standard only giving dimension will be updated to a design standard.
